### 40 Days of Prayer

IVCF students led a time of prayer and fasting preceding their Outreach Week. The IVCF staff leader said,

“It seemed to be the deepest [outreach], with the deepest impact, deepest conversations, and deepest participation by students **propelling them into evangelism all of the time!**”

### “Where’s U Boat at?”

One of the I-zones was a painting of a lighthouse, sandy beach, and wild seas. Students were asked to place their paper “boat” on the painting depicting the current state of their life. Some were on the beach (safety/peace) while others were on the raging seas of turbulence leading to conversations of Christ.



### Unique “Question Mark”

Gathering around tables students were given 10 common apologetic questions providing their own responses to as many questions as time allowed. Then they brainstormed questions at their tables. Mark answered these questions for over an hour spawning many additional one-on-one conversations.



### Ali left home...

...after numerous arguments with his father about God. Raised Muslim, Ali spent the last 7 years exploring various paths to God. As a very intelligent political science major, widely read in philosophy, he was pretty skeptical of religion - especially Christianity.

During January break, he served alongside two Christian men at an organization which drove drunk people home. Their compassion really struck Ali. When thieves stole all his car tires, the men paid for new tires even though they didn't have much money. This generous act sparked new interest in their kind of faith in Christ.

Ali attended a “Question Mark” asking very thoughtful questions and talking with Mark afterward. Finally he said, **“I’ve come to believe in God, and now Jesus is my Savior and Lord!”**

### Student Led Outreach Cafés

Many of the 8 Outreach Cafés were student led. For one Outreach Café a girl saw a poster on a bathroom stall decided to attend and brought a couple of friends... **who decided to follow Christ!**
